Formative Evaluation of Workbooks for the Kha Ri Gude Mass
Literacy Campaign

22 October 2014

1. PURPOSE/ AIM OF THE PROJECT

- 1.1 This evaluation seeks to address the efficiency (quality) of workbooks used in the Kha Ri Gude Mass Literacy Campaign. The purpose of the formative evaluation is to provide feedback on the workbooks in order to guide adjustments to future editions. This document serves to set out specifications for professional and technical expertise from a suitably qualified service provider to conduct the formative evaluation.

2. BACKGROUND

- 2.1 On 3 February 2006, the Minister of Education established a Ministerial Committee on Literacy (MCL), which was required to inter alia develop a strategic plan for a mass literacy campaign in South Africa to enable about 4.7 million illiterate citizens who had never been to school to achieve a level of basic literacy, and thereby enable South Africa fulfill its commitment, made in Dakar at the Education For All meeting in 2000, of reducing illiteracy by 50%.
- 2.2 The Kha Ri Gude Mass Literacy Campaign was launched in February 2008, with the intention of enabling 4,7 million adults above the age of 15 years to become literate and numerate in one of the eleven official languages. Achieving this goal will enable South Africa to reach its United Nations (UN): Education For All (EFA) commitment made in Dakar in 2000 - that of halving the country's illiteracy rates by 2015.
- 2.3 The formative evaluation of a sample of Kha Ri Gude workbooks and materials; in numeracy, literacy, learner and facilitator guides; forms part of the Department of Basic Education's (DBE) efforts to assess the delivery of the Kha Ri Gude Mass Literacy Campaign in order to improve implementation. The workbooks would be evaluated against international quality standards and the curriculum outcomes of the programme, affording the program independent assurance of the workbooks as well as an opportunity to enhance the programme by identifying areas requiring revision for future editions.

3. SCOPE OF WORK/ DELIVERABLES

- 3.1 The service provider will be required to develop a quality rubric based on national standards as specified by the South African Qualification Authority for

the Unit Standards for ABET (Adult Based Education and Training) level 1 and international standards for Adult Based Education and Training against which to assess the workbooks in the programme. The relevance and alignment of the workbooks in terms of the curriculum outcomes for the programme would also have to be considered. The assessment will be applied to the following workbooks:

3.2 In addition to reviewing the workbooks, the service provider will be required to assess the DBE criteria for developing materials in order to ensure that the development of materials is completed under consistent quality standards in this programme.

4. REQUIREMENTS

- 4.1 In view of the scope of the evaluation work, the bidder should have expertise in research or evaluation of education projects including the development/evaluation of education Learning and Teaching Support Materials (LTSMs) in the relevant languages including Braille. This must be clearly indicated in the Curriculum Vitae (CVs). The bidder must submit **CV's of all key persons** who will be participating in the project.

- 4.2 The bidder must submit a **minimum of two contactable** (name of contact person, telephone number and email address) referees for whom the service provider has recently provided similar services. The information must be completed on the template below:

- 4.3 The bidder must submit a **Project Management Plan** which indicates the evaluation approach, timeframes, a brief literature review on adult based education and related learning materials in South Africa and other developing and developed countries, a quality control plan and a draft assessment rubric to be used to evaluate the workbooks.
- 4.4 The bidder must submit a **sample of previous work** in the development/evaluation of LTSMs as a measure of the quality of work the service provider is able to produce.
- 4.5 The bidder must provide a **risk management plan**.
- 4.6 The bidder must provide a **full breakdown of cost** for the supply of service as per deliverables in table under paragraph 3.3 with a ceiling price. A ceiling price is the price paid for the total estimated time of completion of all deliverable and including all expenses inclusive of VAT for the project and should be fixed for the full duration of the project.
- 4.7 The bidder **must fully complete and sign** all the attached SBD forms (SBD4, SBD8, SBD6.1 and SBD9).
- 4.8 The bidder must submit the **original valid tax clearance certificate/s**.
- 4.9 Bidding as a Consortium or Joint Venture:**
- (a) The agreement signed by nominated members of both/ all consortium or joint venture partners;
 - (b) State the leading company;
 - (c) A member of the leading company must have attended a compulsory briefing session (if any);
 - (d) Completion, signing and submission of all bidding (SBD) forms separately (per company within the consortium/ joint venture);
 - (e) Submission of all bidders' (within the consortium/ joint venture) original valid tax clearance certificates.
- 4.10 Bidding with an intention of subcontracting certain tasks:**

Bidders who do not comply with all the requirements in paragraph 4 (4.1 to 4.10) will be disqualified.

5. CONDITIONS

5.1 It is expected that the formative evaluation will be concluded within **8 weeks** from the signing of the contract.

5.2 The material compiled by the Department of Basic Education (DBE) may not be used in any form or for any purpose other than the purpose stipulated in the agreement. If the service provider wishes to use such material in any other form or for any other purpose, including, but not limited to, workshops, media release and the like, the service provider must submit a written motivation for such use to the DBE. The DBE will request approval from the designated officer in whom copyrights are vested. Only once the designated officer has granted written approval will the DBE convey such written approval to the service provider and will the service provider have permission for such use.

5.3 In the case of any material compiled, developed, researched, commented on, or evaluated on behalf of the DBE as a result of this contractual agreement with the service provider, or any other form of material, irrespective of whether in a completed form or otherwise, all intellectual property rights relating to such material will vest in the state. The service provider may not use any such material without first having obtained written approval as envisaged in clause 5.2.

5.4 **Penalty clause:** The Department reserves the right to cancel the contract with the appointed service provider with immediate effect should challenges be experienced with the service delivery and customer service to the Department's officials and it is not resolved to the satisfaction of the Department.

5.5 The Department reserves the right to change the terms of reference before the award of the tender.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2011

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE)

NB: BEFORE COMPLETING THIS FORM, BIDDERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF B-BBEE, AS PRESCRIBED IN THE PREFERENTIAL PROCUREMENT REGULATIONS, 2011.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated not to exceed R500 000 (all applicable taxes included) and therefore the **80/20** system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.5 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

- 2.1 **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;
- 2.2 **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;

- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

80/20 or 90/10

P_s = Points scored for comparative price of bid under consideration

5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
